Annual Fund Raising Event

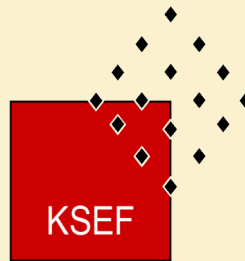

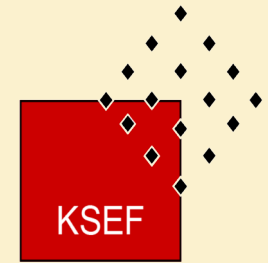

What is the Kappa Scholarship Endowment Fund, Inc.® (KSEF)?

The KSEF is a 501 (c) (3) non-profit tax exempt foundation established for the purpose of providing financial assistance to deserving graduating seniors of the District of Columbia Public High Schools and Public Charter High Schools, who seek to further their education through attendance at an accredited institution of higher learning. The Fund is administered by a volunteer Board of Directors and is audited annually by a certified public accounting firm.

The KSEF was organized on February 16, 1984 by the Washington, (DC) Alumni Chapter of Kappa Alpha Psi Fraternity, Inc. to address its educational commitment to the Washington, D.C. community.

Since it's establishment, the KSEF has awarded over \$2 million in scholarships to more than 700 graduates of the DC Public and Charter High Schools.

What are the goals for KSEF?

THE GOALS OF THE KSEF ARE TO:

- Acquire and utilize resources to provide scholarships to assist promising students who are seeking a quality college education.
- Assist youth in achieving the skills and knowledge required to compete in a rapidly changing technological world.
- Enhance the quality of life in our community through the development of future leaders.

Who May Apply for A Scholarship?

Any Washington, D.C. Public high school or Public Charter high school graduating senior planning to attend a four (4) year accredited institution of higher learning may apply.

Applications are available in the high school counselor's office or online at www.ksef-inc.com.

How Are Recipients Selected?

Applications are reviewed and evaluated by volunteer members of the Board of Directors of the KSEF®. Selections are based on GPA, financial need, extra curricular activities and community service. Scholarships are awarded each spring for the following academic year.

Are Contributions Tax Deductible?

YES! the KSEF has been granted tax-exempt 501(c) (3) status by the Internal Revenue Service. It is also a charitable organization eligible for contributions through the *United Way of the National Capital Area, Combined Federal Campaign* and is a qualified member of the *D.C.
